Time is Running Out to Protect Golden Gate Park

On Thursday May 24 San Francisco's Planning Commission and Recreation and Park Commission could approve turning seven acres of Golden Gate Park into an artificial turf sports complex with 150,000 watts of sports lights — right across the Great Highway from Ocean Beach. The lights will be lit from dusk until 10:00 p.m. every night of the year, impacting couples who stroll along the promenade at sunset, families who stargaze at Lands End, and "fire worshipers" who enjoy the fire rings on the beach in the dark.

The project will introduce additional paving into what is now a vegetated area, build bleacher seating for over 1,000 spectators, and cut down over 55 trees. Artificial turf is made up of a gravel base, old tires or other infill, and plastic grass. The Audubon Society has described the 7 acres of artificial turf as the environmental equivalent of paving 7 acres of parkland with an asphalt parking lot.

Turning the western end of Golden Gate Park into an urbanized soccer complex runs counter to the 1998 Golden Gate Park Master Plan, the 2004 National Register listing, the city's own Coastal Plan, and the 2012 Ocean Beach Master Plan.

It is ironic that while the City is removing tiny bits of concrete in the Paving to Parks program, it is planning to destroy the habitat and beauty of a wide swath of the western edge of Golden Gate Park.

There are financial considerations, also — the project budget has been quoted at between \$9.6 and \$12 million. The Beach Chalet fields could undergo a simple renovation with natural grass for much less, and the rest of the 2008 Bond funding could be used to fix up other playing fields in San Francisco. This would release more funding for our parks in the upcoming 2012 Bond.

In a few years San Franciscans will be drinking the water from the aquifer under Golden Gate Park. If the artificial turf run-off has to be treated for toxics, then the rainwater that falls on the field will have to be drained to the sewage treatment plant and processed. In addition, the lighting could have a projected cost of over \$200,000 over the 10 years constituting the life of the project. Artificial turf is usually warranted for 8 to 10 years. With the completion of this project, San Francisco will have over 30 acres of artificial turf on RPD land — where will the City find the funding to pay for replacing it all when it wears out in 10 years? Kids can't play soccer on old gravel and wornout plastic grass.

Now is the time to speak out against this project. Write to Mayor Ed Lee and the Board of Supervisors. Ask them to keep real grass and NO sports lights in Golden Gate Park.

Plan to attend the May 24 hearing and any Appeal hearings.

There is only one Golden Gate Park — let's preserve it as parkland for the enjoyment of everyone today and for future generations.

Land Use & Housing Committee Efficiency Units: What are They Exactly?

I did not even know there was a zoning category of an "efficiency unit." The California HCD (Housing and Community Development) code definition for an "efficiency unit" means a Unit containing only one habitable room. A good concept for people who don't need a large apartment i.e. seniors, retirees, young adults, transitioning youths from foster homes, and students.

Presently an efficiency unit in San Francisco is defined as an unit of 220 sq/ft plus a bathroom and closet. The new definition will be the same as allowed by the State of California, a minimum of 150 square feet of living area, exclusive of bathrooms, closets, and cooking area. For San Francisco, the entire area, including the closet, bathroom will need to be at least 220 square feet.

The potential problem is that there are new zoning categories in which the density limits have be removed. This new zoning are designated NCT and M category zoning in the Eastern Neighborhoods. The NCT zoning can be found in the Market Octavia Area Plan, Eastern Neighborhoods, Glen Park, and probably in any new area plan on transit corridors. It was to be inserted for Japantown until Rose Hillson and I strongly objected. The Planner stated there was little difference between allowing a unit for every 400 sq/ft of a lot and no density limits because of open space requirements and exposure requirements. However, with all the changes that can occur with Planning, who knows if the proposed changes to the Zoning Administrator's authority to remove or waive open space, exposure, and parking requirements for noncomplying structures certain districts will not be expanded to NCT zoning districts.

Another consideration is the problem with the Art Academy's 17 buildings which are in being used for student housing in violation of the City's Planning Codes. The concern is that of conversion and removal of precious residential units to student housing. Supervisor Wiener has proposed a new ordinance which includes prohibition of converting residential housing to student housing. What will occur if residential housing is purchased by an educational institution and converted to a number of efficiency units? Will they be on the open market or rented exclusively to students?

Will the City's inclusionary housing be in effect? What about unit mix to require two or three bedrooms to allow families to remain in the City? Will any of the units be rentals? Could this result in pseudo-Student Housing and allow converting residential units to numerous "efficiency units" along NCT transit corridors?

Admittedly, I don't know enough about efficiency units, but we all need to know all of the issues; we need to follow this.

from the ceiling, broken lights go unrepaired, leaking water seeps through and corrodes the murals, chunks have been carelessly carved out of the art, and gashes and chips mar many of the exposed and fragile frescoes.

This has all been allowed to happen despite the fact that Coit Tower already generates more than enough revenue for the city every year to keep it in good shape. According to city records, the city has been receiving \$633,000 annually from Coit Tower concessions and elevator fees but spending just 7% of that – less than \$44,000 a year – on Coit Tower!

Proposition B will put in place a new policy directing city officials to more wisely use some of the **existing resources** generated by Coit Tower to preserve and protect it, while keeping commercial activities and private events appropriately limited so that **Coit Tower remains a public place**, not a private party venue for sale to the highest bidder.

Coit Tower and its murals are unique and priceless San Francisco treasures. But they aren't being treated that way.

Coit Tower needs our help. Vote Yes on Proposition B. Let's protect Coit Tower.


