## EMERGENCY FIRE PREPAREDNESS

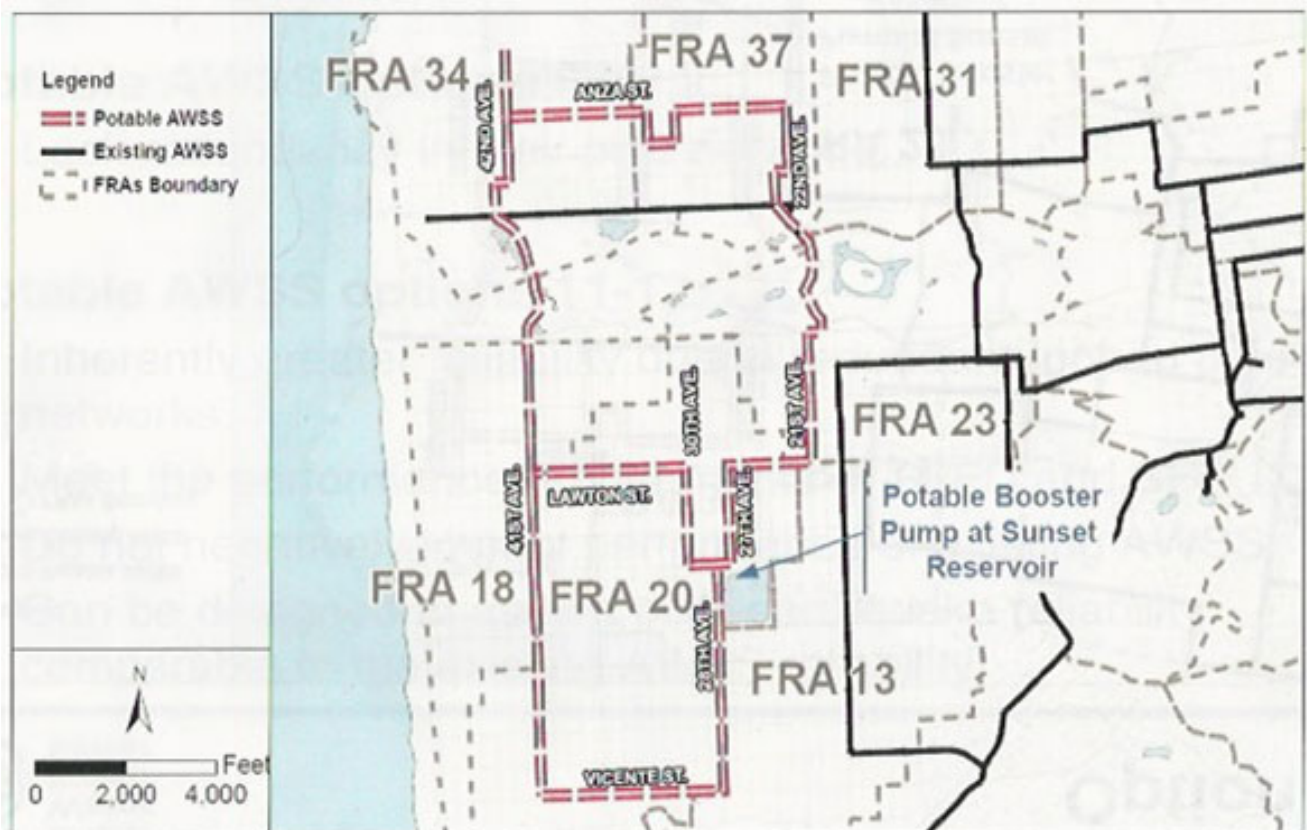

Recently, in the November issue of the Westside Observer, there was an article, Plan to Protect Neighborhoods from Fire Abandoned, describing San Francisco as unprepared for another earthquake and fire. The source of the information was a former official who retired 10 years ago. That report did not take into account numerous improvements in technology and planning. The public should be aware of these advances. Graciously, on January 31, 2018, the SF Public Utilities Commission (SFPUC) and the SF Fire Department (SFFD), both agreed to discuss the article. At the meeting was the Assistant Deputy Chief Anthony Rivera. and John Scarpulla from the SFPUC. At the meeting much progress was presented, however, looking at the progress of this issue today, it is moving at a glacial pace.

At this meeting the SFPD and the SFPUC explained that the SFPUC has countless water engineers and plumbers, while the SFFD does not. Furthermore, the SFPUC explained that they listen carefully to any request from the SFFD, since the SFPUC never fought a fire. This congeniality was sincere and heartfelt as these two agencies worked together to describe a plan they developed to fight fire in San Francisco.



## INDEPENDENT EXPERT

Adding to the expertise of these two agencies was an independent fire authority, Charles Scawthorn, who would provide additional advice as these agencies developed a plan to fight fire. Included in the fire plan is a robust hydraulic model to provide reliable information about what damage can occur in a 7.8 earthquake. After a designed 7.8 earthquake, the existing system was estimated to be 47% reliable and many upgrades were required.

**This system is also named the High Pressure Water Supply Network.**

## WATER SHORTAGE

The Auxiliary Water Supply System (AWSS, though often referred to on manhole covers and hydrants as HPFS for High Pressure Fire System) is a high pressure water supply network built for the city in response to the failure of the existing emergency water system during the 1906 earthquake. The necessity for more water was a paramount concern. Therefore, three existing reservoirs needed to be repaired due to leaking. Leaks can also reduce water pressure. Repairing these leaks saved 150 million gallons of water a year. This existing system has 11.5 million gallons of water. When the Sunset reservoir is added to the Ancillary Water Supply System (AWSS), an additional 11.5 million gallons of water will be available. Then, the University Mound Reservoir will be added to provide another 70 million gallons of water to the AWSS. Lastly, water from Lake Merced could add another 1 billion gallons of water to the system. Then there would be enough water to fight fire.

## FIRE BOATS

During the Loma Prieta earthquake of 1989, fire hydrants were damaged in the Marina. However, one fire boat was crucial in putting out the fire there. Realizing the importance of fire boats today, two additional fire boats have been added. These fire boats can pump water into an AWSS along the piers beside the Embarcadero. The Bayview district could also benefit from an extension of the AWSS along the Bay pier leading south.

## NEW PIPE TECHNOLOGY

Japan has numerous earthquakes, the last one being 9.0. This earthquake was considered to be the 5th largest earthquake ever recorded and the worst in Japan. The pipe designed and used in Japan to fight fire is called Kubota pipe. This pipe has movable joints and did not fail after the Fukushima earthquake. A date for the installation of the Kubota pipe in the Sunset/Richmond district is set for 2019. This pipe will be part a loop system that can be separated with valves, so that should one section of the pipe fail, pressure can be maintained elsewhere. In combination with the loop system, firefighting hose advancements now

allow fire hose to extend over a mile from a fire engine, with supplemental water pressure. Flow meters can detect leaks during practice runs and during an emergency use of the AWSS. The Kubota pipe is hard enough that it can be hammered under intersections without excavation. The fact the pipe is metallic allows it to be located in the future, unlike ceramic pipe. Each coupling is capable of bending 5-8 degrees and can be fasten with stainless steel bolts. Kubota pipe removed after twenty years of use was found to be completely intact and capable of far longer service.(2)

## LIQUEFACTION AT LAKE MERCED

A study of the 1906 earthquake explained just how vulnerable Lake Merced is to earthquakes. After the 1906 earthquake "a bridge was broken in two places ... At one break the west piece was shoved 12 or 14 feet past the other section. The west end of the intermediate piece failed to join the section at the west bank by 6 or 7 feet. The west section that remained with the bank was 4 to 6 feet lower vertically than the intermediate piece."(1) Piping here and nearby Lake Merced must be especially robust with numerous fail-safe protections.

## FLEXIBLE WATER SUPPLY SYSTEM

The previous article mentioned a Flexible Water Service System (FWSS) that was suggested as a substitute for the more expensive AWSS. However, Chief Anthony Rivera inspected an existing FWSS system in Berkeley. He discovered that the FWSS pipe was too heavy to be useful in fighting fire in Berkeley and was abandoned. Each segment of the FWSS pipe weighs 350 pounds and needed to be installed with expensive equipment. This system could not be installed by a Neighborhood Emergency Response Team (NERT) during a fire as was suggested. The Chief explained this FWSS pipe was actually designed for oil well producers.

## SUMMARY

Lastly, the new firefighting system designed for San Francisco must be flexible and adaptable so that when new technologies develop, they can



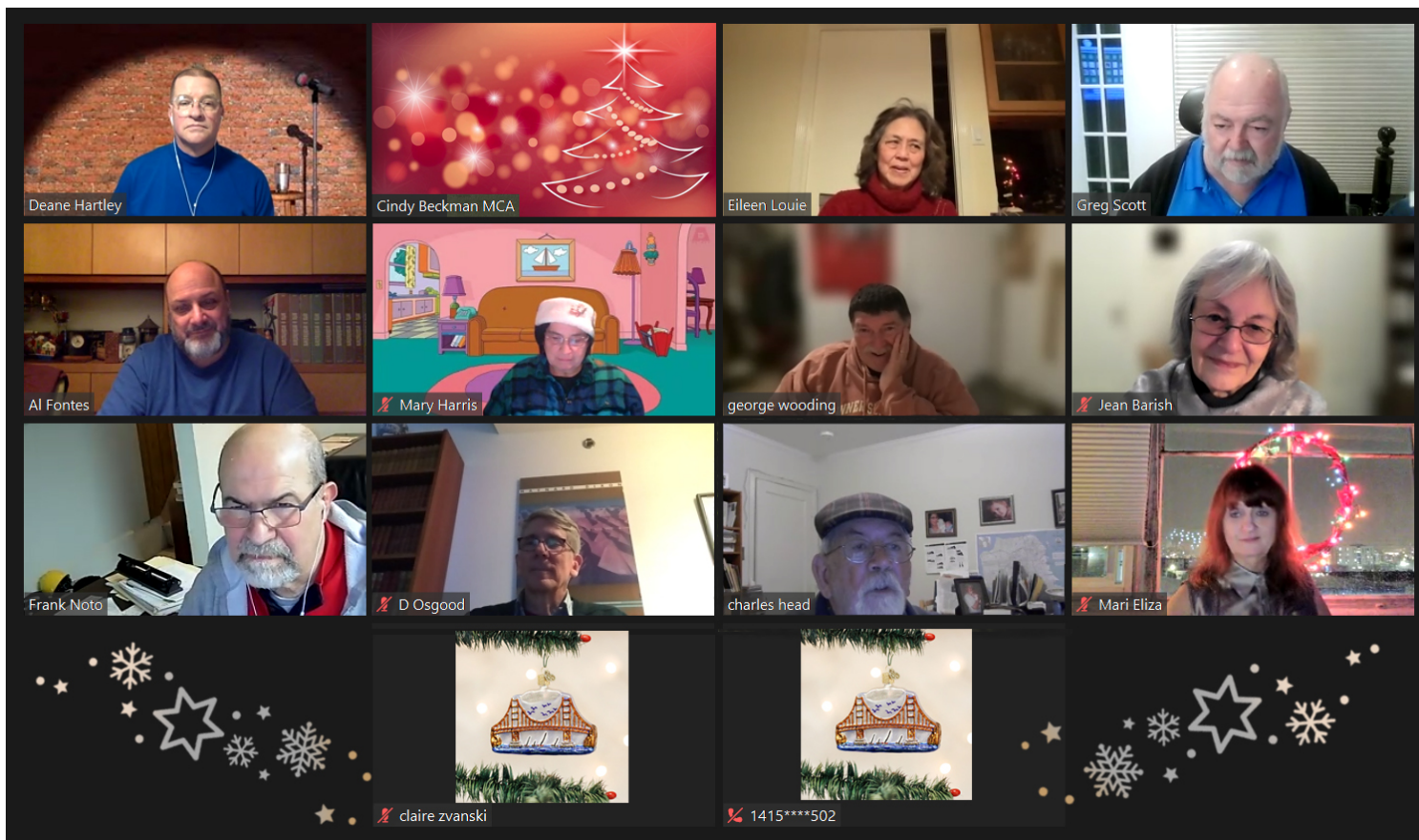
be added to the new system easily. After this meeting with the SFFD and the SFPUC, with the hope of more improvements later, I felt optimistic about our fire protection plan and strategy.

### MINUTES OF NOVEMBER 17, 2020 CSFN ASSEMBLY MEETING ON ZOOM

- I. **CALL TO ORDER:** President Head called meeting to order at 6:42 p.m.

  - A. 13 member organizations present (13 delegates + 1 alternate)

- III. **PROGRAM:** November 2020 Local Election Recap from Christopher Bowman

  - A. **PRESIDENT:** (Head) Attended BOS meeting. 2-hour discussion on memorandum of understanding with City and Police Officers' Association - passed with provision of further negotiations before December BOS meeting. BOS also passed Contractors Reform and Transparency regulations and all-electric buildings act for new buildings. Supervisor Mandelman upset that no mental health conservatorships have been carried out.
  - B. **VICE PRESIDENT:** (Rogers) Meeting this evening with Sierra Club to make them more aware of Treasure Island cleanup concerns.
  - C. **RECORDING SECRETARY:** (Beckman) October General Assembly Meeting Minutes presented in the newsletter.
    1. Approval of Minutes: No comments, additions or corrections made. With no revisions requested, **minutes accepted as presented**.
  - D. **CORRESPONDING SECRETARY:** (Fontes) Received the key to the mailbox and will coordinate with Cindy on picking up the file box.
  - E. **TREASURER:** (Scott) Financials presented through October. Nominal activity - \$80 in revenue, \$13 expenses. \$60,000+ in bank. Loss for the year to date.

## THE “BLANDING” OF SAN FRANCISCO CONTINUES

Supervisors vote to increase sign clutter

Hills buried in high-rises, oversize utility boxes, transit resources plastered in advertising, copycat high-rises, large vinyl awnings stretching from store to store (right), state-imposed density rules, planning exemptions given freely to out-of-town developers, buildings in parks, billboards that never go away—these are some of the things that make San Francisco look more and more like Anytown, USA. No wonder so few filmmakers come here now.

And now more Starbucks signs. Despite citizen opposition, the Board of Supervisors unanimously passed an ordinance by Supervisor Stefani on November 30 to double the number of storefront signs that merchants, including chain stores, can put up. There were no provisions (or amendments) to reduce the size of signs or improve their quality. Cheap plastic signage and tacky vinyl awnings remain OK. More of the above can be expected. It can't be claimed that this ordinance will improve the city's unique character or respect its cultural districts.



Merchants have lived with the current sign regulations for decades, and they didn't seem to be clamoring for this ordinance. Only 1 identified merchant spoke for the ordinance at the committee hearing while 3 citizen volunteers spoke against it. (Public comment was not allowed at the board.) The Merchants Association got an early Xmas gift they hadn't been asking for. According to the Planning Department summary, this ordinance actually came about because **one** merchant in district two complained to Supervisor Stefani about sign enforcement. She basically tried to get him off the hook by legalizing excess signage in 53 planning districts around town. (Actually, according to a Planning staffer, that merchant's signs are so bad that he'll still be out of compliance despite this ordinance.)

The Planning Department campaigned for this ordinance instead of just providing unbiased facts. They consistently displayed artwork that minimizes its effects. The only before-and-after shots they provided in their lengthy summary (right) showed a relatively tiny awning set back from the front of the building. The only difference between the two shots is the small (approximately 7 sq ft) lettering on the awning. In fact, lettering on awnings can be 20 to 40 sq ft. They completely ignore the fact that, if the shop already had lettering on its awning, Stefani would allow them to add the projecting sign (as big as 32 sq ft—much larger than what's depicted). Subsequent artwork did the same. Both planning commissioners and supervisors called-out this deceptive omission. Planning should have felt shamed. They even displayed current views of chichi Colorado mining towns with their restored red brick buildings, high-end shops and well-regulated signage. No explanation was given how the Stefani ordinance would create anything but the opposite. Ironically, if you peek behind the clutter in the photo at top, you'll see similarly handsome century-old buildings hidden behind. If only they could be seen, property values would certainly increase, customer curb appeal would go up, and San Francisco's unique character would be greatly enhanced. Unfortunately city planners don't apply that vision here.



The Planning Department summary included lots of economic data to convince us we're in a downturn (so stipulated!) but provided no evidence that this ordinance will help merchants during this pandemic. It's not the struggling merchants who can afford new signage, but McDonald's can.

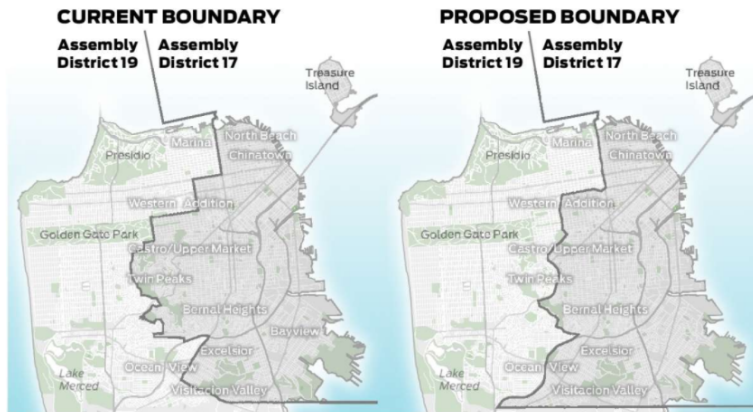

## CSFN Government and Election Report

For the February 15, 2022 election, all voters citywide will have the School Board recall measures and the Assessor- Recorder contest listed on their ballot. Voters residing in Assembly District 17 will also have the opportunity to vote in the Member of State Assembly contest.

### School Board Recall Measures

Three Board of Education member recall measures appear on the ballot in this election due to the certification of three recall petitions in October 2021 (per local law, a “measure” includes a local recall contest). If more voters choose “Yes” than “No” in any of the recall contests, the Mayor will appoint a replacement(s) to serve the remainder of the four-year term(s) for the recalled Board of Education member(s). Regardless of the outcome of this election, contests for these same seats on the Board of Education (Seat 1, 2, and 3), will appear again on the November 2022 ballot.

Voters in the State district 17 election will choose a candidate to serve until the start of the next term in January 2023. If no candidate receives a majority (50%+1) of votes in this primary election, a general election between the two candidates receiving the most votes will be held in June 2022. Regardless of the outcome of this election and the potential general election, this contest will appear again on the June 2022 ballot. For the February 15, 2022 election, all voters citywide will have the School Board recall measures and the Assessor- Recorder contest listed on their ballot. Voters residing in Assembly District 17 will also have the opportunity to vote in the Member of State Assembly contest.

#### School Board Recall Measures

Three Board of Education member recall measures appear on the ballot in this election due to the certification of three recall petitions in October 2021 (per local law, a “measure” includes a local recall contest). If more voters choose “Yes” than “No” in any of the recall contests, the Mayor will appoint a replacement(s) to serve the remainder of the four-year term(s) for the recalled Board of Education member(s). Regardless of the outcome of this election, contests for these same seats on the Board of Education (Seat 1, 2, and 3), will appear again on the November 2022 ballot. The three School Board members involved in the recall election are Allison Collins, Gabriella Lopez, Faauuga Moliga

#### Assessor-Recorder Contest

This contest appears on the ballot due to a vacancy in 2021. Voters in this election will choose a candidate to serve until the start of the next term in January 2023, with this contest appearing again on the November 2022 ballot.
