VOTE NO on Proposition L San Francisco's \$2.6 BillionTax



Proposition L will add a new ½ cent regressive sales tax on San Francisco's poor, seniors and in firmed from 2032 – 2053. The tax should generate \$2.6 Billion over that 30-year period.

The San Francisco County Transportation Authority (SFCTA) has made a mess of City transit finances. Cost

SFCTA is comprised of all 11 members of the Board of Supervisors sitting as a body to oversee travel, to "plan, fund, and deliver transportation projects to improve travel choices."

The San Francisco Municipal
Transportation Agency (SFMTA), on
the other hand, is a seven-member
board; its members are appointed
for fixed, staggered terms by the
Mayor, subject to confirmation by
the Board of Supervisors. Board
members are limited to three terms,

The SFMTA Board of Directors is responsible for, among other things, hiring the agency's executive director.



Although separate agencies, The SFMTA works for and answers to the SFCTA.

In 2003, kind-hearted, yet unaware residents passed an innocuous ½ cent, regressive sales tax called Proposition K that would last until 2032 and generate \$2.8 Billion in

revenue. This tax was supposed to help fund transportation for thirty (30) years, then be completed.

So why is the SFCTA trying to merge Proposition L with Proposition C? Proposition K will still provide over \$100 Million annually for the next eight years.

The SFCTA is financially desperate. After twenty years, they have almost no ability to borrow on Proposition K. The SFCTA claims it needs Proposition L's 30-year life span to borrow against future revenue streams.

The SFCTA can also push forward \$560 million in debt and grant payments on to Proposition L.

On Tuesday, July 26 Julie Kirschbaum, SFMTA's director of transit, told the SFCTA — which consists of all 11 SF supervisors — "we need to find the most sustainable path for service, where we're increasing service faster than economic recovery ,but not so fast that we run out of resources."

Jeffrey Tumlin, Executive Director of the SFMTA states, "I'm allocating far more service to downtown right now than ridership alone can justify." Tumlin further says that "ridership at its Embarcadero and Montgomery stations remains at about 30% of its pre-pandemic level, but the level of service it offers is closer to what it was before COVID-19 hit in 2019."

The Board of Supervisors voted 9–2 to adopt a resolution from Supervisor Dean Preston and progressive colleague Supervisor Connie

Chan, urging SFMTA to reinstate all lines and pre-COVID service hours by Dec. 31, 2022.

The SFMTA is deliberately hemorrhaging money at a tremendous rate.

SFCTA officials say they expect to receive \$1.1 billion in federal dollars to aid its recovery, but half of the SFCTA's federal funds are already spent retaining services and preventing employee layoffs. Another \$300 million will also be

services and preventing employee layoffs. Another \$300 million will also be spent this year on recovery.

Proposition L needs a 2/3rds vote to succeed. Please vote NO on L. Citizens defeated the June, 2022 Proposition A, a \$400 Million General Obligation SFMTA Bond Measure. Proposition L will be seven times larger than the intelligently defeated Proposition A. The citizens of San Francisco deserve a better post-covid plan from the SFCTA.

The City government has not done a good job for San Francisco residents. Voters are becoming more aware of the tricks and traps of our increasingly expensive tax legislation.

Post-Pandemic Light rail and buses are running empty. SFCTA "safe streets" are making surrounding streets less safe. Bicycles, skateboards and pedestrians cross streets with impunity. People are working from home. San Francisco's mass transit was designed to take people to a deserted downtown. Downtown San Francisco is a ghost town.

From April 2020 to July 2021, the city lost nearly 7% of its population, going from 873,965 to 815,201 residents. According to a report published recently by Redfin ,San Francisco is the number one city in the United States where homebuyers are moving out or looking to move out. Tourism is down by over 50%. Homelessness has increased to an average of over 8,000 people per day, yet the homeless cannot afford to ride mass transit.

Our transportation leaders continue to spend money based on their old, pre-covid transportation financial models. By creating Proposition L — a 30-year, $\frac{1}{2}$ cent, regressive sales tax — the SFCTA will have the authority to issue limited tax bonds in an aggregate principle amount not to exceed \$1,910,000,000.

Opponents of this measure say San Francisco is still recovering from the COVID-19 pandemic, and with local businesses just starting to recover, now is not the right time for another tax measure. It's especially unnecessary to spend so much on public transit when people just aren't commuting as they did before. With existing transportation projects delayed and millions over budget, we need to hold our transportation systems accountable before we vote to approve even more funding for them.

Between the federal infrastructure bill and other recently-passed funding measures, there is already plenty of money going towards transit improvements in San Francisco — it's time to give San Francisco taxpayers a break.

Taxes in San Francisco are already high enough. Your great-grandchildren will be paying off Proposition L.

Please VOTE NO on Proposition "L" San Francisco's messed-up Sales Tax for Transportation Projects. San Franciscans deserve better governance.

Proposed Amendments to CSFN Bylaws 2022 July 29, 2022 Committee Meeting Elections

B. Term

1. Officers shall serve for a two (one) year term beginning at the close of the May meeting or until a successor is elected.

Committees

Committee chairs...etc. to end of phrase no change. Committee chairs may only serve as chair of one standing committee at a time or during a term. If selected/elected/nominated by committee members for more than one committee, then the candidate must decide which committee he/she will chair and decline election/nomination to any other committee for the duration of the term. Since the chair of the Executive Committee is a requirement of the office of Vice President, the Vice President shall be excepted from this restriction and allowed to chair another standing committee if elected by the members of that committee.
