

## Background

The City of San Francisco fought a lawsuit against PG&E for over 20 years to clean up toxic waste from the East Marina harbor. In 2021, they finally settled for \$190 million. Now, instead of doing the cleanup, San Francisco Rec & Parks Department (RPD) is proposing to simply relocate the boats to a new harbor that PG&E will build at its expense.

This deal allows a stunning 85% of PG&E's toxic waste to remain in place while forever altering a San Francisco treasure, the open waterfront of the Marina Green. Since its creation in 1915, the promenade of the Marina Green has been the City's "front yard" providing visual relief from the East and West Harbors and the congestion of its urban setting. The proposed 235-slip harbor would be located directly in front of it, blocking the unobstructed bay view, lining the walkway with fences and lights, and limiting public access further by giving parking to berth holders.

The RPD is doing the residents of San Francisco a bad turn by taking away the last bit of open waterfront in the city and offering to retrofit a former toxic waste dump as a recreation area in return.

San Francisco's Marina Green is unique, historic, and popular. San Francisco renters and homeowners frequently go there to escape their apartments for fresh air, relaxation, and exercise. The waterfront view of Golden Gate Bridge sunsets, Angel Island serenity, Alcatraz intrigue, and waterfowl playmates does not exist anywhere else. The iconic view draws events, visitors, and tourists from around the world. Who Owns the Waterfront?

#### Where We Are To Date

A lot has happened in September on this question, and at this point it's fair to say that the issue is very visible in the community and at City Hall. Hundreds of emails have gone to the RPD commissioners, to the supervisors and to the mayor. Aaron Peskin and Asha Safai have also declared their opposition to the project and have agreed to join a 10/11 community meeting organized by *Keep The Waterfront Open (6pm, Sports Basement, in the Presidio).* 

RPD is playing a defensive game, trying to obfuscate the fundamental drivers for the project and not being transparent with the Recreation and Parks Commission. Initial attempts to understand the genesis of the project design haven't been successful so far.

## And it is increasingly apparent that multiple aspects of the project do not make sense:

- Pollution remediation, as we discussed, which is compounded by the Laguna Street Outfall meaning sewage flowing directly into Gashouse Cove.
- Breakwater design that is far from a guarantee to eliminate the need for dredging one of the critical arguments of the project's proponents.
- Overall economics: for RPD, the Marina revenue from berths is about \$5 million, whereas golf alone brings in more than \$14 million. And RPD wants to spend \$190 million to add just 65 slips. The math just doesn't work.

Maybe the commissioners will have the courage to follow their conscience and shut the project down at the commission meeting on 10/19; if not, our bet is that the issue could become mayoral campaign fodder. Questions about financing and effects on the Marina Green, flood zones and bay waters and shifting sands remain unanswered. We need to hear from engineers on the wisdom of expanding the breakwater beyond the wave organ. How likely is it to work in the bay floor soils in that area of the bay? More questions posed to the commissioners by Bill Clarke.

Informing voters about our judges is essential for our democracy, By StopCrimeSF member John Trasviña is the immediate past Dean of the University of San Francisco School of Law and has served in three Democratic presidential administrations.

While I have great respect for my former colleague Berkeley Law School Dean Erwin Chemerinsky, he is profoundly wrong in his attack on StopCrimeSF's program to educate voters about the decisions of San Francisco Superior Court judges. California law entrusts its citizens with the power to retain or reject sitting judges. His approach would deprive voters of important factual information about the decisions of those judges and how they affect our daily lives. We need more light, not less, on the public decisions of judges.

Earlier this year, I was inspired to join StopCrimeSF, a grassroots group of San Francisco neighbors from all walks of life who share a fervent concern about the criminal justice system and the wellbeing of all San Franciscans. I have devoted my career to public service, immigrant and civil rights, and education. Charter Amendment: An amendment to the city Charter

Legislation Introduced:

**230986 Charter Amendment** - Mayor Approval Required for Certain SFMTA Budget Proposals] Sponsors: Safai; Peskin. Charter Amendment (First Draft) to amend the Charter of the City and County of San Francisco to provide that the Mayor must affirmatively approve in writing certain San Francisco Municipal Transportation Agency (SFMTA) proposals as part of the SFMTA's proposed budget or budget amendment; proposals subject to the approval requirement include changes to fares, parking meter maximum rates, and hours or days of parking meter operation; at an election to be held on March 5, 2024. ASSIGNED UNDER 30 DAY RULE to Rules Committee.

**230987 Charter Amendment** - Establishing the Department of Emergency Management in the Charter Sponsor: Safai. Charter Amendment (First Draft) to amend the Charter of the City and County of San Francisco to establish within the Charter the Department of Emergency Management, the position of the Director of the

Department, and the Director's qualifications and appointing authority; at an election to be held on March 5, 2024. ASSIGNED UNDER 30 DAY RULE to Rules Committee.

#### **Expense Documentation Guidelines** by Greg Scott

So... it's tax time again. Most of us were granted a 6 month extension to October 15<sup>th</sup> to complete the dreaded tax forms. To be successful in withstanding the scrutiny of the tax examiners documentation is Key!

The same requirements exist when requesting a reimbursement from CSFN. A receipt alone does not have all of the required information. Businesses and non-profits like CSFN also have rules or procedure's that require that an expenditure be approved or authorized. This is all covered below.

Think of it like the 5 W's you heard about if you ever took a journalism class... accounting procedures require expenditures include documentation of WHO, WHAT, WHEN, WHERE & WHY. Some but not all of this information will be on most receipts.

WHAT, WHERE & WHEN are covered by most receipts.

WHO is usually clear, but not always, The person requesting reimbursement is always clear, but Who else is not usually there. So for example – when incurring an expense for refreshments or a meal – it must be clear who was there to enjoy the food, or to whom it was provided. There is also a requirement to know WHO authorized the expenditure.

Plus documenting WHY it is an appropriate expense for the business/exempt organization is required. CSFN, like many businesses, adopts a budget and other expenditures are approved by a vote of the general assembly (GA). This is one way the business purpose of an expenditure is made clear. As a

501 C not for profit, CSFN MUST be clear that money spent is in furtherance of our exempt purpose (our business). This means that we cannot expend charitable funds for other purposes that are prohibited (some political expenditures) or that benefit individuals or entities and not our exempt purpose. This is referred to as inurement. Spending charitable funds that do not meet these standards could result in loss of our exempt status. This covers the WHY of an expense,

As your Treasurer and a CPA I take these requirements seriously.
