President Glenn Rogers Message:

GREEN COMMITTEE: named the Green Committee and would discuss all things that are good for the environment.

IMPROVED SOLAR PANELS: Most recently, researchers have synthesized a highly durable solar cell made from perovskite- a common crystal structure (in its natural form a calcium titanium oxide mineral) -in a breakthrough that could revolutionize the solar industry with longer lasting solar panels. Today, solar panels deteriorate over time and eventually need to be replaced, not so with this new material.

However, a new product by GAF Energy which produces a solar roof material that can be installed with nails and is able to withstand 130 mph winds is now also available. This new material is cost effective, being half the cost of a Tesla roof. It is reported this company is the largest producer of solar roofing.

CONCRETE BATTERIES: Another innovation that has been developed is a concrete battery. The inexpensive ingredients of this battery are carbon black, water and concrete. This new battery which is fundamentally a super capacitor can charge quickly, has a long lifespan and can discharge quickly also. This new invention will reduce dependency on lithium.

CROP LAND LOST TO SOLAR PANELS: More than 5,000 square kilometers of the world's surface was covered by solar photovoltaic (PV) panels in 2018 – 1655 times more than in 2003. In 2018, around 27% of all solar panels were installed on cropland. Therefore, the food production loss is calculated to be enough to feed 4.3 million people. By the year 2050, there could be a 16-fold increase in food production losses. Maybe we should consider another alternative.

WIND ENERGY: The east coast has less land available for solar power, therefore, it is considering the alternative of wind energy. One estimate believes wind energy could provide 11 times the projected global electricity demand by the year 2040. Although, California presently has enough solar energy on a summer day to require no need for fossil fuels, the situation changes in the evening. Wind energy could provide electrical power in the evenings in California. This would be good news for the environment and California both. Let's encourage our politicians to bring this to fruition.

Keep the Great Highway a Highway: By Glenn Rogers: Because of their unique characteristics, two sections of the Great Highway should be considered separately when permanent closure is contemplated. One section is from Lincoln Way to Sloat Blvd. (Northern Section), and the other is from Sloat Blvd. to Skyline Blvd. (Southern Section).

The Southern Section of the Great Highway has been ignored year after year. As more erosion occurs, inaction will destroy this section. Is this neglect a calculated ploy designed to render it unsafe and ensure its conversion into a park is inevitable? If this section is ignored through another rainy season, it is likely to end up in the Pacific Oceans

Is the Ordinance to put the Great Highway closure on the ballot an attempt to circumvent the will of the district and make this into a City-wide issue? This is an unfair democratic process...(more)

Although our State Constitution gives local voters a voice over where to locate subsidized projects, the Agency says RM4 overrules local voters!

Promised "tenant protections" can't legally be funded with bonds. Accordingly, RM4 admits "allocation(s) for Tenant Protections may be...redistributed" elsewhere.

RM4 is a monstrous tax increase that hurts renters and owners, families and seniors, and burdens our grandchildren with five decades of crushing debt


